### Schedules

Shiksha is open Monday through Friday, from 8:00am to 5:30pm.

#### Daycare Schedule

We follow a daily schedule to establish and maintain a routine that creates comfort as well as discipline for the students.

### Policies

#### Sick Policy

If your child/children is sick, he/she has to stay home the following day. If it exceeds more than two consecutive school days, a doctors' note is required to return to class.

#### Payment Policy / Attendance

Payment is due on the first Monday of each month for all All 11 months of fees (excluding our summer break, August). If it is not received by the sixth day of the month, a \$20 late fee will be charged. If your child is absent for 10 days or less due to sickness or vacation, you are responsible for paying the full month fees. If your child misses class for a whole month, then half of the month's fees will be incurred. A notice of one month should be provided if you plan on pulling your child out of Shiksha. If you fail to do so, a month's fees will be incurred.

#### Late Pickup Policy

A late fee will be charged if the child is picked up after 5:30pm.

#### Emergency Card

- The Emergency Card will contain the names and addresses of child pick-up and drop-off authorized-persons information.
- Medication on Premises
- Allergy Information
- Child's Insurance Information
- Vaccine records of children should be sent along with the application form.



#### **Required Supplies**

Parents are supposed to provide seasonal bedding consisting of a fitted sheet, a small blanket, and a small pillow from home. These beddings are going to go home on each Friday, and would be brought back on every Monday morning (if Monday is a holiday, then the following working day).

Please send an additional, seasonal jacket and extra clothes in a ziploc bag labeled with your child's name. We would retain this in case of accidents.

Daily, nutritious lunch should be provided from home. We will not be able to heat any lunches, as per guidelines. Please remember to be mindful of any food allergies in the entire class! Snacks will be provided.

Please remember, no personal belongings should be sent from home. Show-and-Tell is only on Friday: you may send an inexpensive toy or item that your child would love to talk about. Please remember, do not send any expensive items.
